The Town Mayor opened the meeting at 7 p.m. and welcomed and congratulated all members on their election to the Council. He had greatly enjoyed his two years in office, meeting and representing the people of Aylesbury as their Mayor.

 Election of Town Mayor (Chairman of the Council) To elect the Town Mayor for 2021/22. Cllr Lambert proposed, Cllr Willis seconded that Cllr Anders Christensen be elected as Town Mayor for Aylesbury for a term of one year. No further nominations were forthcoming and on being put to the vote this proposal was carried unanimously.
RESOLVED: That Cllr Christensen be duly elected Town Mayor for the municipal year 2021/22.

RESOLVED: The Mayor signed the Declaration of Acceptance of Office before the Town Clerk & Proper Officer of the Council.

The Town Mayor thanked his proposer, seconder and all members for electing him and also expressed his gratitude to Cllr Smith for his two years serving as the town's First Citizen.

2 Apologies

To receive and accept apologies of absence from Town Councillors. There were no apologies received.

3 Declarations of Interest

To receive any pecuniary or non-pecuniary declarations of interest **RESOLVED**: That the Town Clerk be delegated by Council the power to grant dispensations (under s101 of the Local Government Act 1972). Receive and grant any applications for Dispensation.

6 **Leader of the Council** (Political Appointment)

To elect the Leader of the Council

It was proposed by Cllr Raja, seconded by Cllr Willis that Cllr Richard Lloyd be Leader of the Council in 2021/22. On being put to the vote the proposal was carried unanimously.

RESOLVED: That Cllr Lloyd be duly elected Leader of the Council in 2021/22.

7 Committee Structure

To agree the following Committee Structure for 2021/22. To agree the membership of each committee according to Council's Standing Orders. The Town Clerk indicated that prior discussions had been held with the respective group leaders and proposed that the existing Committee Structure be retained as follows, politically balanced.

RESOLVED: The following committees shall be the Standing Committees of the Town Council, and the current Terms of Reference shall remain as agreed, subject to amendments as appropriate in Standing Orders to reflect size of committees.

- 2. Finance Committee 7 members: 6 Liberal Democrat, 1 Conservative,
- 3. Planning Committee 9 members: 7 Liberal Democrat, 2 Conservative
- 4. Direct Services Committee 9 members:7 Liberal Democrat, 2 Conservative
- 5. Communities Committee 9 members:7 Liberal Democrat, 2 Conservative
- 6. Grants Committee 7 members: 6 Liberal Democrat, 1 Conservative.

RESOLVED: The Town Clerk then read out the proposed memberships of each committee and this was unanimously agreed (see Appendix A to these minutes).

8 Appointment of Committee Chairs

The Town Clerk referred to prior discussions and a proposal was made to elect members for Chairs of the standing committees.
