

### MINUTES OF A MEETING OF THE GRANTS COMMITTEE OF AYLESBURY TOWN COUNCIL HELD ON 19 OCTOBER 2022, AT 7.00pm, COUNCIL CHAMBER, TOWN HALL, 5 CHURCH STREET, AYLESBURY

Cllr Lloyd welcomed everyone present and called the meeting to order at 7.00 pm

# 1. APOLOGIES

**RESOLVED:** To receive and accept apologies for absence from the following councillors, noting those councillors who were asked to substitute. Cllr Bateman (prior commitment and Cllr Lambert substituting), Cllr S Morgan (illness and Cllr Lloyd substituting), Cllr A Morgan (illness and Cllr Wadhwa substituting), Cllr Chapple (family commitment).

# 2. DECLARATIONS OF INTEREST & REQUEST FOR DISPENSATIONS

Cllr Lambert declared an interest in the application from Youth Concern as he is an Ambassador for the charity.

No requests for dispensations were made.

# 3. MINUTES OF THE MEETING HELD ON 22 June 2022

# 03-22/23 Autumn Leaf

## £1,727

**RESOLVED:** The committee unanimously agreed to support Autumn Leaf by awarding a grant of  $\pounds$ 1,727 for funding towards a free Christmas dinner for members of the Autumn Leaf club and also for the Thursday Club which is joining the Autumn Leaf Christmas dinner event.

# 04-22/23 Aylesbury & District Table Tennis League £1,300 (withdrawn)

Application made for funding for the replacement of 3 table tennis tables. **RESOLVED:** Not to make any award as this application was withdrawn by the organisation.

# 05-22/23 Broughton Community Action £3,000

**RESOLVED:** The committee unanimously agreed to support Broughton Community Action by awarding a grant of £3,000 to support their work in providing more support to the local community and to extend their work in the community café.

The organisation had requested  $\pounds 2,000$  but after hearing from their representatives and having a clearer understanding of the funding required, Cllr Lloyd proposed and Cllr Baldwin seconded that the organisation be awarded an additional  $\pounds 1,000$  which the committee unanimously agreed to do, and awarded an additional  $\pounds 1,000$  to the organisation.

# 01-22/23 Space (Aylesbury)

**RESOLVED:** The committee unanimously agreed to award Space (Aylesbury) £5,000 towards the staff costs for a Project Co-ordinator,

Project Administrator and Counselling staff supporting weekly counselling groups and one to one counselling support.

## 02-22/23 Lindengate

### £5,000

**RESOLVED:** The committee unanimously agreed to support Lindengate By awarding a grant of £5,000 towards the funding for the running of specialist group led, nature based, activities to improve people's wellbeing.
