The Town Clerk reported his intentions to cancel the Heritage Open Day events at the Town Hall and Cemetery Tour in line with protocol. He would also make necessary decisions during the period of formal mourning.

Resolved: That the Town Clerk should make any necessary decisions, in respect to council administrative and services business as per guidance and protocol during the formal period of mourning.
