# 1. Apologies for Absence

## 2. Mayor's Announcements

The Mayor formally noted the passing of the Deputy Town Clerk, Mr Mark Broughton. The Mayor, Leader of the Council and Town Clerk will be attending the funeral on behalf of the Council. The Council's thoughts and best wishes are with Mark's family.

The Town Mayor referred to the list of Mayoral Engagements previously circulated and in addition highlighted that he recently attended three events organised by the Aylesbury Hundreds Rotary Club. He also planted a tree at Buckingham Park School for the Queen's Platinum Jubilee with the Lord Lieutenant of Buckinghamshire.

#### 3. Leader's Announcements

The leader of the council announced that he attended another HS2 meeting and that overnight deliveries have started to arrive at the back of Hawkslade. Deliveries are carefully monitored and some initial noise issues have already been resolved. Cllr Lloyd reiterated that should any councillors receive any comments, feedback or issues regarding HS2 from residents to pass these on to the HS2 community engagement team so they can be looked into immediately.

The section 17 notice for the Aylesbury section of HS2 still hasn't been published. Publication is anticipated in March.

The leader asked councillors to vote for "Live in the Park" as Best Family Friendly Event at the Litte Ankle Biters' Awards. A link to the voting website has been sent to all Town Councillors.

Cllr Lloyd advised that the Council will shortly be involved in the consultation of the Emerald Way (Cycleway) Extension and more information will be provided in the coming weeks.

The Council's Community Officer, Benedicta Lasoye, delivered an abridged Dementia Friends Session for all councillors. Key messages included:

- Dementia is not part of growing old
- Dementia is caused by diseases of the brain
- Dementia is not just about losing your memory it can affect your communication, motor skills, sequencing and vision too
- It is possible to live with Dementia
- There is more to the person that the Dementia

#### **Since 2016**

- The Town Council has created 2749 dementia friends.
- Delivered 116 dementia friends' sessions
- Started #TuesdayTunes, in partnership with Aylesbury Libraries. The project connects people's memories through music.
- Worked with the Waterside Theatre, who are a great supporter and partner.
  They have organised Dementia Friendly screenings and in partnership with the
  Town Council delivered three events based on Music, Moves and Memories in
  the Second Space of the theatre. The theatre helped promote Dementia Action
  Week with La Voix in 2021.
- The Council has received accreditation from the Alzheimer Society that Aylesbury is "Working towards being a dementia friendly town"

#### a) Arla Liaison Group

Cllr A. Sherwell attended the last liaison group meeting on behalf of Cllr T. Hunter-Watts. Cllr Sherwell reported that the Arla in Aston Clinton is 10 years old and business is going well. Arla had bought a piece of land next to their site on which they had planned to build warehouses. However, the plans have fallen through and they are currently assessing what to do with the land.

Arla has sought permission from the Environmental Agency to increase their production to the full capacity.

In the last few years Arla has done considerable work to mitigate any noise related issues.

#### b) Armed Forces Covenant

Cllr D. Summers reported that she recently attended a passing out parade at The Royal Military Academy Sandhurst, where all officers in the British Army are trained to take on the responsibility of leading their soldiers.

A presentation was given to all attendees which highlighted the work being done at Sandhurst, who are very happy to visit schools and give a talk on the apprenticeships available within the forces. Cllr Summers highlighted how impressive the work is that is being done in Buckinghamshire, to support those who served their country, with housing, financial assistance, if required, change in career, education, wellbeing and more.
